3. Candidates working in Government Organization / PSU must route their application through proper channel, if their department rules require so.
4. Engagement of Consultants will be on full working day basis and their place of work will be New Delhi
5. The prescribed qualification and experience should have been acquired on or before 1<sup>st</sup> January, 2020. Qualifications should be from approved recognized institutions.
6. The selection process will be based on academic qualifications and experience and will also include written test And / Or group discussion and/ Or interview as may be decided depending on the total number of eligible applicants.
7. Documents in support of (i) Qualifications (ii) Experience& (iii) Age, etc have to be produced in “originals” as and when called for written test And / Or group discussion And / Or interview.
