5. Candidate should have strong oral & written communication skills with excellent working knowledge of computer (MS Word, MS Excel & Power Point etc.) and presentation skills.
6. The selection process will be based on academic/professional qualifications, experience and may also include Test of Writing Skills/Group Discussion and/or Interview as may be decided depending on the total number of eligible applicants.


